# APPLICATION FOR G3 MUSIC COURSE (2026 – 2027) INFORMATION SHEET FOR APPLICANTS

APPLICANTS ARE TO APPLY FOR THE COURSE <u>ONLINE</u> BY <u>WEDNESDAY</u>, 16 JULY 2025

LATE APPLICATIONS WILL **NOT** BE ACCEPTED.

#### INTRODUCTION

The application for the G3 Music Course<sup>1</sup> (2026 - 2027) conducted in centres is open for students who will be in Secondary 3 in 2026. Applicants must <u>not</u> be from schools that offer the Enhanced Music Programme (EMP), Music Elective Programme (MEP) and G3 Music.

#### **BACKGROUND**

The two-year upper secondary G3 Music Course is for students with a strong interest to develop their knowledge and skills in music beyond the foundations of primary and lower secondary music curriculum. Students with musical background from music CCA, school-based music programmes or external music activities are encouraged to apply.

### **G3 MUSIC COURSE CURRICULUM**

The G3 Music Course integrates Listening, Creating and Performing experiences to engage students in purposeful music learning. Students will explore digital music-making (including Digital Audio Workstations) and expand their music understanding and appreciation through five Areas of Study (AoS):

Area of Study (AoS)	Genre / Tradition
1. Western Classical	Solo Instrumental Music, Chamber Music, Symphony
2. Asian Music	Music of Malay Traditional Dances, Chinese Ensemble
	Music, Indian Ensemble Music, Gamelan (Javanese)
3. Jazz	Traditional Jazz, Swing, Bebop, Cool Jazz
4. Popular Music	Late 1960s Pop-Rock, Synth-Pop, R&B/Soul
5. Music in Multimedia	Music in Film and Television

#### **APPLICATION PROCESS**

- 5 Applications are to be submitted <u>online</u> at <u>https://go.gov.sg/2026g3mcourse</u>.
- The Selection Exercise comprises <u>two</u> mandatory components. **All applicants are** required to complete <u>both components</u> regardless of external certifications held. Late applications will not be accepted without valid reasons (e.g. medical certification).
- 7 Details for Components 1 and 2 of the Selection Exercise are provided below:

## Component 1: Audition (online submission)

Applicants must ensure that submitted videos are their own performances and have not been doctored or digitally enhanced.

#### Selection of Pieces:

- Two solo pieces of different styles, moods and/or traditions, reflecting applicant's current abilities, should be selected and performed in the video recording.
- Applicants are discouraged to play two movements from the same piece so that a wider range of repertoire can be presented.
- Applicants can submit two solo pieces, each on a different instrument (including voice), should they choose to do so.
- If the pieces selected exceed five minutes in total duration, applicants should record only a selected portion of the piece. (Note: If the video recording exceeds five minutes, only the first five minutes of the submission will be assessed)

#### Specifications:

- Applicants are to be in school uniform for the video recording.
- The following must be in clear view in the video recording(s) and not be obstructed by music stands or other objects:
  - Applicant's face
  - Applicant's posture when playing the instrument (e.g. arms, hands, fingers, instrument; recording of piano performance should include sight of pedalling; recording of cello performance should be of the full body, including sight of feet)
- Video recording must not be edited. It must not be recorded more than three months before the application deadline. Expensive professional recording services are not necessary and strongly discouraged.
- Instrumental accompaniment and verbal introductions are not required.

#### Submission:

- Upload the video(s) to Google Drive and submit the sharing link on the online application.
- Ensure file-sharing permissions are set as 'Public' or 'Anyone with the link'.
- Acceptable file formats: MP4, M4V, AVI, FLV, MOV
- File name: school name\_student's full name

- Applicants should preview and test the links to their video-recordings before submitting the online application form.

# Component 2: e-Listening Test (Conducted at applicant's own school on Friday, 15 August, 3pm)

In this one-hour e-Listening Test, applicants will listen to 8 - 10 short musical extracts, taken from a range of musical traditions, and respond to 25 multiple-choice questions.

The scope of the questions will include the identification or description of the following:

- Melody (e.g. accidentals, articulation, contour, intervals, melodic devices, phrase structure and mood)
- **Tonality** (major and minor keys up to 3 sharps and flats, pentatonic mode)
- **Harmony** (chords, I, IV, V, vi in Roman numerals and chord symbols)
- **Rhythm** (e.g. dotted rhythms, syncopation, triplets, rhythmic devices)
- **Time Signature** (simple and compound duple, triple and quadruple)
- Tempo
- **Instrumentation and tone colour** (instrument families, how they are played, description of tone colours of musical instruments from western and non-western traditions)
- **Texture** (e.g. call and response, monophony, unison, homophony, polyphony, heterophony), and **functions of musical layer(s)**
- **Dynamics and Expression** (e.g. loud/soft, performing decisions)
- **Form or Structure** (e.g. Binary, Ternary, Rondo, Theme and Variations, 12-Bar Blues, popular song structures)
- **Notation** (staff notation)

If an applicant were to miss the e-Listening Test without any valid reason (e.g. medical), his/her application will be considered void.

8 Applicants may approach their school's Music coordinator for assistance should they face issues.

#### **G3 MUSIC CENTRES**

9 Successful applicants are required to attend weekly three-hour lessons conducted in the afternoon at designated centres. All centres are co-educational.
