

### Annex B: Options for DMA Settings After School Hours

- The DMA setting during school hours will be determined by the school, with parents/guardians given a choice to opt for alternative DMA settings after school hours. The following table outlines the different levels of restrictions, controls and monitoring for the different DMA options after school hours.

	<b>Default Setting (Continue with school DMA settings)</b>	<b>Option A (Modify DMA settings)</b>	<b>Option B (Disable DMA Settings)</b>
	For parents/guardians who want their child's/ward's use of the devices to be restricted only to teaching and learning, and prefer to leave it to the school to decide on DMA settings after school hours. It will follow the same DMA settings set by the school during school hours.	For parents/guardians who want more leeway over the use of the device, and prefer to take charge of the level of restrictions for their child's/ward's use of the device after school hours.	For parents/guardian who do not want their child's/ward's use of the device to be regulated by DMA after school.
Protects students from objectionable content	School default web content filtering: <ul style="list-style-type: none"> <li>• Violent/extremist</li> <li>• Sexual/pornographic</li> <li>• Gambling-related</li> <li>• Social media sites</li> </ul>	Parents/Guardians can apply additional content filtering	No content filtering after school.

2. Parents/Guardians may wish to consider the following questions before deciding on the choice of after-school DMA option which is best for your child's/ward's learning.

**a. Child's/Ward's current device usage habits**

- How much time does my child/ward spend on his/her device?
- How well is my child/ward able to regulate his/her device usage on his/her own?
- Does my child/ward get easily distracted while doing online learning?

**b. Parental/Guardian involvement**

- How confident and familiar am I with managing my child's/ward's cyber wellness?
- Are there existing routines and open conversations on the use of the Internet at home?
- Am I aware of how to prevent different types of cyber threats that my child/ward might face?
